

# Surecomp Cookie Policy

Surecomp Business Solutions Ltd. ("**Surecomp**", "**we**", "**our**") recognizes the importance of your privacy. In this cookie policy ("**Cookie Policy**"), we aim to inform you about the use of cookies on our website, <u>www.surecomp.com</u> ("**Website**") and our RIVO product provided as Software as a Service, found at <u>https://app.rivo.trade/login</u> (together the "**Services**").

We use cookies with our Services for a variety of reasons, among others, to provide, maintain, and improve our Services, to optimize our offerings and marketing activities, and to provide our visitors and users ("You", "Your") an informative, personal, and friendly experience as possible (for example, user validation and authentication and monitor and improvement of the overall performance of our Services).

This Cookie Policy explains what Cookies are and provides information about the Cookies we use with our Services, the different types of Cookies used, their purpose and how to disable them.

## What are Cookies?

A cookie is a small piece of text sent to your browser by our Services. It helps the Services to remember information about your visit, your actions, and preferences such as login, language, font size and other display preferences over a period of time, so you don't have to keep re-entering them whenever you come back to use our Services or browse from one page to another. Placing cookies can make your next visit easier and the website more useful to you.

#### The Cookies We Use:

- 1. Essential/Technical Cookies: Strictly necessary cookies are essential to enable you to navigate the Website and RIVO<sup>™</sup> platform use certain features. Because these cookies are strictly necessary, we do not need to ask for your consent to use them. Without these strictly necessary cookies, the Website and RIVO<sup>™</sup> platform cannot be operated and provided to you. These Cookies, for example, let us recognize that you have created an account and have logged into that account to access the website / RIVO<sup>™</sup> platform. They also include cookies that enable us to remember your previous actions within the same browsing session and secure our Services and your interactions with our Services. We use security cookies to authenticate users, prevent fraudulent use of login credentials, and protect user data from unauthorized parties.
- 2. Analytical/Performance Cookies: These cookies are used by us or thirdparty service providers to analyze how the Services are used and its performance. For example, these cookies track which pages are most frequently visited, and the locations our visitors come from.
- 3. Functionality Cookies: We may use cookies that allow us to offer you enhanced functionality when accessing or using our Services. Our functionality cookies are used to remember choices you make such as language preference, country location, or other online settings or keep track of your specified preferences and interests. Functionality cookies enable us to improve and enhance the presentation of content on our website.
- 4. Third Party Cookies: We may use cookies to collect information about your activities on our website and other websites to provide you with targeted advertising. We may also allow our third-party service providers to use cookies on our website for these same purposes, including collecting information about your online activities over time and across different websites.

We additionally use social media cookies and plug-ins which enable us to recognize the user, based on the relevant social media profile and analyze certain data in relation to the user's social media profile. We utilize LinkedIn's tools for cookies. The LinkedIn button and social widgets are services allowing interaction with the LinkedIn social network provided by LinkedIn Corporation.
