



Website Privacy Policy

Surecomp Business Solutions Ltd. and its subsidiaries and affiliates ("Surecomp") respects the privacy of the users of this Website. This Privacy Policy outlines the steps Surecomp is taking to protect users' privacy and the limitations in doing so.

Collection of Personal Information. Cross-Border Transfer, Processing and Storage of Personal Information. As a global organization, Surecomp may transfer your personal information worldwide to any Surecomp's affiliates, or to its business partners or other third parties worldwide acting on its behalf, for the purposes of processing or storage of the personal information pursuant to this Policy.

Children's Privacy. Surecomp is committed to protecting the privacy needs of children and we encourage parents and guardians to take an active role in their children's online activities and interests. Surecomp does not knowingly collect information from children under the age of 16 and Surecomp does not target its Website to children under 16.

Disclosure of Information as Required by Law. Surecomp may be forced to disclose Tracking Information or Personal information if required to do so by applicable law or by a competent governmental or judicial order to prevent any illegal or harmful activities.

Data Retention. Surecomp keeps your personal information only so long as Surecomp needs it to provide the products or services you requested, fulfill all the other purposes described in this Policy, and for other essential purposes such as complying with Surecomp's legal obligations, resolve disputes, establish legal defenses, conduct audits, maintaining security, detecting and preventing fraud and abuse, enforce our agreements and comply with all applicable laws. This is also the case for anyone that Surecomp shares your personal information with and who carries out services on Surecomp's behalf. Retention periods can vary significantly based on the type of information and how it is used. Surecomp's retention periods are based on criteria that include legally mandated retention periods, pending or potential litigation, our intellectual property or ownership rights, contract requirements, operational directives or needs, and historical archiving. When Surecomp no longer needs to use your personal information and there is no need for Surecomp to keep it to comply with our legal or regulatory obligations, resolve disputes and enforce our agreements, we'll either remove it from our systems or depersonalize it so that we can't identify you.

Disclosure of Information as a Result of Reorganization. Surecomp may also be forced to disclose Tracking Information or Personal Information as part of a corporate reorganization, restructuring or merger activities, to the extent required to consummate such activities.
